Chuck Sams moved the Oregon Environmental Restoration Council recommend a long-term distribution policy of 5% to the Oregon Investment Council for inclusion in the Oregon Environmental Restoration Fund’s Investment Policy Statement [Scenario 5a: 5% spend with a \$30 million annual spend ceiling and \$15 million floor].
